



Individual interactions & system performance




How surgical team members are connected






How the pharmacy department is connected with other systems


Subsystem (Pharmacy department)

Subsystems (Patient wards)




Interactions between subsystems

Dynamic manpower adjustment: department level




Dynamic manpower adjustment: individual level

Medication flow and queue




Phone calls from patient wards to Pharmacy

- Counter service every 11 minutes







- Alignment




