THE 9TH INTERNATIONAL ORTHODONTIC CONGRESS

Resident Forum e-Posters Information and Procedures

Definition:

e-Posters are electronic displays of important educational value and of significant new investigative works. e-Posters will only be listed on the 9th IOC website.

Rules and Regulations on e-Posters:

- 1. The 9th IOC accepts up to two abstract applications.
 - Note: abstract submission concluded on March 31, 2020.
- 2. All accepted abstracts will be uploaded and listed on the official 9th IOC congress website.
- 3. e-Posters are an electronic display of research. Authors of accepted abstracts who wish to create an e-Poster presentation are asked to create a file using Power Point or Keynote slides. All accepted abstract authors will receive enough space to upload up to 10 slides. No animation should be used in the e-Poster.
- 4. e-Posters will need to be uploaded by August 15, 2020, if you wish to create.
- 5. Directions for uploading an e-Poster will be emailed in August to all authors of accepted abstracts. 9th IOC reserves the right to remove any e-Poster that does not meet its standards.
- 6. Disclosure of Financial and/or Beneficial Interest is an electronically signed statement include with the uploading form indicating whether or not the presenter or the presenter's family has a financial and/or beneficial interest in the product or service related to their e-Poster.
 - Note: The disclosure statement must be completed or upload of the e-Poster will not be accepted.
- 7. Disclosure of Visual Enhancement is an electronically signed statement included with the uploading form indicating whether or not the main author or the co-author uses enhanced, modified, or altered visuals in their e-Poster.
 - Note: The disclosure statement must be completed or the upload of the e-Poster will not be accepted.
- 8. Authorship and Assignment of Rights is an electronically signed statement included with the uploading form indicating that the main author will assign the rights to the abstract and e-Poster to the WFO.
 - Note: The Authorship and Assignment of Rights statement must be completed or upload of the e-Poster will not be accepted.

- 9. Certificate of Attendance at Resident Forum will be available for all the authors (main author and co-authors) of accepted abstracts for their participation in the Resident Forum program. This certificate will be emailed to the email address registered when you completed congress registration, after the congress. Please note that Residents Forum presenters are required to submit digital data (e-poster) along with the abstract.
 - Note: Payment of the registration fee is required to receive this certificate.
- 10. Any costs incurred to participate in the e-Poster program are the sole responsibility of the author/clinician. The 9th IOC will not pay for registration fees, travel, or hotel expenses and will not provide any honorarium, stipend, or any other form of payment.
- 11. Advertising is not permitted in the e-Poster program. No commercial promotion is allowed.
 - Note: Violation of this policy will result in the immediate removal of the e-Poster.
- 12. In case the publication of an abstract/presentation contains identifiable information about patients, the patients' prior consent for the research to be published is required. For all abstracts/presentations that include identifiable patient details (e.g. gender, age, illness, location) or images, written informed consent for the publication of these must be obtained from the patient (or their parent or legal guardian).

It is the author's responsibility to obtain written informed consent for publication of clinical details and/or clinical images from the patient/parent/guardian/relative of the patient. A respective statement needs to be included on the poster.
